

Instructions on how to complete a Route Update Request form

About the form

A Route Update Request form is required to update any Gazetted Network/Legally Enforceable Network (LEN). We developed this document to provide instructions on how to complete the Route Update Request form.

Route Update Request forms are categorised into one of these two options:

- Add /Amend Route, Add /Amend/Remove Conditions, Amend/Remove Restrictions – Different forms exist for each Class of Heavy Vehicles
- Remove Route / Add Restriction – One form to update the change for any Class of Heavy Vehicles

How to complete the form

This section explains which fields should be filled in based on the request type in each of those forms. The fields are mandatory to action any Gazette request.

Definitions

Terms	Definitions
Route	A set of connection roads and infrastructure allowing a vehicle to travel from origin to destination and includes any way-points or list of roads to include into network.
Notice title	Name of the relevant Commonwealth Gazette Notice that the network relates to.
Network	Published network of roads that identify where various vehicle categories can drive without a permit provided they meet specific requirements in a published Notice.

Terms	Definitions
Vehicle type	A description of a vehicle, type of vehicle or category of vehicles to which an authority, exemption or condition applies.
Vehicle description	Description of the vehicle.
Road condition	A condition imposed for protecting road infrastructure or preventing or minimising an adverse effect on the community and risks to public safety arising from heavy vehicles.
Travel condition	Condition stating to ensure that access to a stated route or area is limited to either or both of the following: <ul style="list-style-type: none"> a) State days or hours (or both); b) Travel in a state direction.
Restriction description	Description of a condition that is imposed on the route. <i>Example: Location of bridge or restricted road limits.</i>
Reason	Explanation or justification of removing or amending a route from a network. Reasons should comply with Section 172 and 179 of the HVNL (Heavy Vehicle National Law).
