## Part 1 Executive summary

#### Section 1 Agreed actions

- Purchase of new float trucks to move specific equipment (rectification)
- 2. To train all staff so they comply with the specific chain of responsibility provisions which relate to packing, loading and load restraint requirements according to the National Transport Commission (The Load Restraint Guide)
- In house driver training booklet based on NHVR guidelines to be created, along with purchase of Load Restraint
  Guide 2018 for each truck, and publication of this driver training booklet for download from Pacific Hire's website,
  accompanied by social media posts.
- To have all staff trained in operation and transport of high-risk equipment (Elevated Work Platform (EWP), yellow card and forklift training) for familiarisation of safe stowing for equipment
- 5. 6 monthly revisions of transport procedures and processes with amendments if and when required to be discussed at monthly toolbox meetings conducted by senior management

#### Part 2 General information

#### Section 1 Purpose

8. The purpose of this enforceable undertaking is to document the undertakings offered to the National Heavy Vehicle Regulator (NHVR) pursuant to Chapter 10.1A of the Heavy Vehicle National Law (HVNL) in connection with a matter relating to an alleged contravention of the HVNL.

#### Section 2 Details

- 9. The commitments in this enforceable undertaking are offered to the NHVR by Pacific Hire Wangaratta Pty. Ltd. (Pacific Hire).
- 10. This enforceable undertaking is given on the day and date that it is accepted and signed by the NHVR. The undertaking and its enforceable terms will operate as a legally binding commitment on the part of the person from



the date it is given.

#### Details of the alleged contravention

- 11. On 29 September 2020 at Dandenong South Pacific Hire permitted another person to drive a heavy vehicle, namely a white 2017 Isuzu tilt tray, registration number 1KU8QU, on a road without ensuring that the vehicle, its components and load, complied with the applicable mass requirements, namely the twin steer axle group of the vehicle exceeded the prescribed mass limit of 11.0 ton, contrary to section 96(1) of the Heavy Vehicle National Law.
- Particulars: Mass detected 15.90 ton, taking into account the applicable mass adjustment the mass alleged 15.40 ton, 140% of prescribed mass limit – severe risk breach.

#### Details of the events surrounding the alleged contravention

- 13. The position of the load on the truck caused the weight to be over limit on the front steer axles.
- 14. The jobsite did not permit the employee to access the deck of the truck in order to properly position the load. It is accepted, however, that it is the responsibility of the Pacific Hire to ensure that all vehicles are compliant with the Regulations, and that all drivers adhere to the regulations regardless of the conditions of the jobsite.

#### The details of any injury or financial loss that arose from the alleged contravention

15. Nil

#### The details of any notices issued that relate to the alleged contravention

16. Pacific Hire has received a summons in respect of the alleged contravention that occurred on 29 September 2020 which is first listed for mention before the Dandenong Magistrates' Court of Victoria on 3 February 2022.

## The details of any existing transport safety management systems at the workplace including the level of auditing currently undertaken

- Pacific Hire has an established comprehensive safety management system in place which encompasses Chain of Responsibility compliance.
- 18. Pacific Hire's existing transport safety management system at the workplace is supported by the following procedures and documents:
  - a. All vehicles are inspected before they exit the property to ensure compliance with the regulations.
  - b. Software system Syrinx is used to document all elements of the hire job, including the inspection and photographs of the inspection including driver fatigue records.
  - c. Software system Destiny documents servicing of all vehicles including safety and vehicle services.
- 19. All vehicles exiting out of the property are inspected to ensure that they are compliant with the regulations.



#### For Subcontractors

- The process on each occasion equipment is loaded onto a truck, the load must be inspected and photographs are taken of every load.
- b. The drivers must attend the main office to obtain details of their job, they are accompanied to the truck, photos are taken, and a check is undertaken.

#### For Employees

- Own drivers inspected by Assistant Manager as it is loaded from jobsites or in the yard
- d Random spot-checks on trucks
- 20. Monthly toolbox meetings conducted with all staff, these meetings are recorded and cover off on the following topics, inter alia:
  - a. New purchases or new equipment
  - b. Any OH&S issues that may have arisen
  - An update from the general manager about matters including safety
- 21. Audits are conducted weekly by the service manager which involve cross-checking a randomly selected truck with the records that accompany the truck.
- 22. A further audit is conducted once per fortnight to cross check servicing and safety inspection on trucks with the records.

#### Any consultation undertaken within the company regarding the proposal of an EU

23. Christian Grzankowski, operations manager, has discussed the proposal of an EU with the Director, Raimond Carlassare. Mr Carlassare is willing to enter the EU. Consultation has been taken regarding the proposed EU within Pacific Hire's management structure. This has been discussed at management level and has been communicated to all staff.

#### Section 3 Statements

#### Statement of assurance

24. Pacific Hire confirms that it is committed to complying with its obligations under the HVNL and ensuring, so far as is reasonably practicable, the health and safety of all workers and others that have the potential to be affected by its business or undertakings.

#### Statement of regret

25. Pacific Hire regrets the incident on 29 September 2020.

#### Statement of ability to comply

26. Pacific Hire confirms that it has the financial and operational capacity to comply with the terms of this enforceable undertaking.

#### Statement of prior undertakings

27. Nil.

#### Section 4 Acknowledgement

- 28. Pacific Hire acknowledges that it is alleged to have contravened section 96(1)(c) of the HVNL.
- 29. The alleged contravention is taken very seriously by Pacific Hire, its Directors and Senior Management, who are committed to providing a safe and healthy workplace to conduct its business in a way that helps protect the environment and the communities in which it operates.

30. Not applicable. No injuries were sustained to workers or members of the public as a result of the alleged contravention.

34. Pacific Hire is committed to ensuring that the behaviour that led to the alleged contravention has ceased and that it will take all reasonably practicable steps to prevent recurrence.

# Commitment to the ongoing effective management of public risk associated with transport activities

- 35. Pacific Hire is committed to the ongoing effective management of public risks associated with transport activities within its business operations.
- Pacific Hire has a commitment to ongoing continuous improvement in how it manages risks associated with its business operations, including the review of new technology when made available.

## Commitment to disseminate information about the EU to workers and other relevant parties in the chain of responsibility

- 37. Pacific Hire is committed to disseminating information about the enforceable undertaking to workers and other relevant parties within the chain of responsibility, including senior and operational management, health and safety management team, Health and Safety Committees and Health and Safety Representatives, workers, and all relevant contractors and subcontractors working for Pacific Hire. This information will be disseminated through:
  - a. For internal employees: Monthly toolbox meetings, regular spot audits by Supervisors and Managers. Driver training program handbooks to be placed in each truck.
  - For external contractors and sub-contractors: communication provided by Department Heads noted in paragraph 12(a).
  - c. All email correspondence captured through document management system CRM.

### Commitment to participating constructively in all compliance monitoring activities of the EU

- 38. Pacific Hire is committed to participating constructively in all compliance monitoring activities of the EU.
- 39. Pacific Hire acknowledges that responsibility for demonstrating compliance with the undertaking rests with Pacific Hire and evidence to demonstrate compliance with the terms will be provided to the NHVR by the due date of each term.
- 40. It is acknowledged that the NHVR may undertake other compliance monitoring activities to verify the evidence and compliance with an enforceable term, and cooperation will be provided to the NHVR including providing details of workshops and training conducted for industry and community benefit.

- 42. As part of this enforceable undertaking, Pacific Hire aims to deliver strategies that focus on benefits to:
  - a. drivers and parties within the chain of responsibility



- the transport industry and the broader community.
- 43. Pacific Hire intends to achieve these outcomes through the implementation of the strategies set out below that aim to educate, train and raise awareness among Pacific Hire workforce and all parties within the chain of responsibility of the importance of complying with Chain of Responsibility laws.

#### **Activities**

#### Activity 1 - Load Restraint Training

#### Scope

To train all staff so they comply to the specific chain of responsibility provisions which relate to packing, loading and load restraint requirements according to the National Transport Commission (The Load Restraint Guide)

#### Details

#### Staff Training:

Load Restraint Training -delivered by Driver Development Australia, Tony Haritonos.

This training provider is not accredited by the NHVR, however the training is particularly relevant and tailored towards Pacific Hire's industry. The training will involve demonstrations using Pacific Hire's own equipment. Pacific Hire was not able to find a NHVR certified trainer in Load Restraint Training who delivers course material relevant to the equipment hire industry. The mainstream Load Restraint Training focuses on securing cargo and pallets rather than equipment. Pacific Hire does not transport cargo and pallets.

#### Course description:

"Loads that aren't restrained properly can injure and cause significant property damage. Your corporate reputation and your financial reputation can suffer if your involved in a load restraint incident. This course is designed to comply to the specific chain of responsibility provisions which relate to packing, loading and load restraint requirements according to the National Transport Commission (The load Restraint guide) The program provides drivers, owners, operators with the basic safety principals that should be followed to ensure the safe carriage of loads. The course starts with a classroom component which covers the Law, the general principals of load restraint, Load restraint methods, selecting the vehicle, Do's and Don'ts. Followed by a practical at the vehicle session."

### Activity 2 - In house driver handbook creation

#### Scope

In house driver training booklet based on NHVR guidelines to be created.

In addition, Invest in NHVR - Load restraint Guide 2018 for each truck.

#### Details

This handbook will be tailored to Pacific Hire to complement the existing third party training to provide additional company specific information. It will include items such as;

- NHVR guidelines, drivers handbook
- Safety charter,
- Restraints,

This book will be kept in each truck. Currently being written by the Operations manager.

An electronic version of this publication will be made available to industry, available for download from Pacific Hire's website. This will be accompanied by a post on Pacific Hire's Facebook and Instagram pages sharing a link to the publication for download, thereby promoting safety and benefiting the broader transport community.

#### **Timeframe**

March 2022

#### Outcome

Each driver will have their own reference manual accessible in each truck. Publishing a link to an electronic version of the handbook will promote safety in the broader transport community.

## Activity 3 - Elevated Work Platform (EWP), Forklift and Yellow Card Training

#### Scope

To have all staff trained in operation and transport of high risk equipment (EWP, yellow card and forklift training) for familiarisation of safe stowing for equipment

#### Details

To ensure all staff truck drivers can safely and legally operate the hire equipment they are transporting to enable safe loading and unloading.

#### **EWP Training**

Boom Lift over 11m

Course Covers the below:

- Planning work including hazard identification and controls
- EWP components and dynamics
- Pre-Operational and Post start checks

#### Yellow Card Training

Covers small vertical lifts, boom lifts under 11m and scissor lifts

## Activity 3 - Elevated Work Platform (EWP), Forklift and Yellow Card Training

Operational checks

#### **Timeframe**

January 2022

#### Outcome

All staff will be trained in operation and basic transport procedures – booms, scissors, fork lifts – all drivers will then hold the high risk licenses and be competent at loading and unloading their trucks.

#### Costs

EWP - 900pp

Yellow card - 450pp

Forklift - 899pp

Number of staff - 18

Total training cost \$40,482.00

#### Output

As described above.

#### Activity 4 – Safety Management System Audit

#### Scope

6 monthly audit and review of transport procedures and processes with amendments if and when required to be discussed at monthly toolbox meetings conducted by senior management.

#### Details

Monthly toolbox meetings are recorded, and transport procedures and processes will be discussed with staff.

Senior management of Pacific Hire will review transport procedures and processes and amend if necessary, on a 6 monthly basis.

#### **Timeframe**

Next review to occur in March 2022, with remainder to occur 6 monthly thereafter

#### Outcome

To ensure that all transport procedures and processes are updated and reviewed by senior management in a regular and documented fashion.

#### Costs

Will be absorbed into existing costs of senior management wages.
